Transportation

Discounted lift tickets will be available for attendees and their families/guests during your stay. No discounts are available on half day tickets and those may only be purchased at the ticket window starting at noon on the day you will ski.

All lift tickets ordered in advance will be delivered to your hotel front desk prior to your arrival. Discounted lift tickets will also be available for purchase onsite during your meeting breaks. Please call 970-923-4544 with questions or for assistance with your order.
